

We are registered with the U.S. Securities and Exchange Commission as an investment adviser. Brokerage and investment advisory services fees differ and it is important for you to understand the differences. What investment services and advice can you provide me?

Our firm offers investment advisory services, which are fully described in our Form ADV Part 2A (“Disclosure Brochure”). Our services include financial planning and investment management services. As part of our standard services, we monitor investments that we manage on a continuous and ongoing basis. There are no material limitations to our monitoring. We accept discretionary authority to manage your assets. This means you give us the authority to implement the recommended transactions in your accounts without your prior consultation, consent or approval. We do not offer advice only with respect to proprietary products. We offer advice on individual stocks, alternative strategies (e.g. long/short funds, market neutral funds), equity and bond mutual funds and ETFs, and independent investment managers. Our services are not subject to a minimum fee or account size, but certain independent managers may impose limitations.

What fees will I pay?

We offer our services on a fee basis. We charge a fee based upon assets under management for investment management services. For these services, the annual fee is prorated and charged monthly. In addition to the advisory fees paid to us, you also incur certain charges imposed by other third parties, such as broker-dealers, custodians, etc. These additional charges include securities brokerage commissions, transaction fees, custodial fees, fees attributable to alternative assets, reporting charges, fees charged by the independent managers, margin and other borrowing costs, charges imposed directly by a mutual fund or ETF in a client’s account, as disclosed in the fund’s prospectus (e.g., fund management fees and other expenses), deferred sales charges, transfer taxes, wire transfer and electronic fund fees, and other fees and taxes on brokerage accounts and securities transactions.

The more assets there are in your advisory accounts, the more you will pay in fees, so the firm may therefore have an incentive to encourage you to increase the assets in your account or manage them in a way where we charge higher fees. You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand

and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.

- Proprietary and Affiliated Products and Services: We recommend investments that are issued, sponsored, or managed by us and affiliates. We also recommend the services of affiliated companies. This results in an incentive for us to recommend (initially and ongoing) those investments and services.
- We and our affiliates refer clients to third-party service providers and are eligible to receive additional compensation for those referrals. See Form ADV, Part 2A, Items 4, 5 and 10 for additional information.

How do your financial professionals make money?

Our financial professionals are compensated based on the following factors and conflicts of interest:

- Certain of our financial professionals may be eligible for additional compensation from our indirect parent company, Focus Financial Partners, LLC (or one of its affiliates), depending on our performance. Eligibility will be determined based on all or a portion of our annual revenues. This potential for increased compensation provides an incentive for these financial professionals to encourage you to maintain and even increase the size of your investment account with us. - Revenue the firm or an affiliate earns from the financial professional's advisory services or recommendations. This results in an incentive to take steps to maximize revenue to the firm or an affiliate, such as recommending certain products or services offered by our affiliates. See Part 2A, Items 4, 5 and 10.
